

Dubai - 'Akhbar Al Tamayoz'

In his capacity as the Ruler of Dubai, His Highness Sheikh Mohammed bin Rashid Al Maktoum, Vice President and Prime Minister of the UAE, issued Law No. 13 of 2023, instituting the Hamdan bin Rashid Al Maktoum Foundation for Medical and Educational Sciences. He also issued Decree No. 32 of 2023, appointing Sheikh Rashid bin Hamdan bin Rashid Al Maktoum as the President of the Foundation.

Objectives

According to Law No. (13) of 2023, the Hamdan bin Rashid Al Maktoum Foundation for Medical and Educational Sciences seeks to bolster government and community efforts to enhance the medical and educational sectors. Additionally, it seeks to foster a culture of creativity and innovation within these sectors while also improving overall performance and services to align with international best practices in these domains. The Foundation also aims to build capabilities across these vital sectors, promoting and supporting scientific research and enabling those leading such initiatives, among others.

The Foundation also aims to support talents and gifted people, build their capabilities, provide an incubating environment for the development of their talents, develop specialized programs for them, and encourage scientific research in excellence and talent, especially in the domains of national priority. Among the objectives are also honoring individuals, universities, institutions, research centers, and other bodies who made achievements in education and medicine at the local, regional, and international levels, as well as everyone who presents distinguished



research that serves society and enriches scientific research, in addition to supporting the sustainability of excellence in fields related to its work in accordance with international best practices.

Board of Trustees

In another legislation related to the Foundation, His Highness Sheikh Hamdan bin Mohammed bin Rashid Al Maktoum, Crown Prince of Dubai and Chairman of the Executive Council of Dubai, issued Executive Council Resolution No. (58) of 2023, announcing the Board of Trustees of the Foundation chaired by Humaid Mohammed Al Qatami. Dr. Jamal Mohammed Al Muhairi will be the Vice Chairman of the Board. Members of the Board include Awad Saghir Al Ketbi, Dr. Khalifa Ali Al Suwaidi, Dr. Ahmed Eid Al Mansouri, Dr. Suleiman Muhammad Al Hammadi, Issa Al Haj Khadem Al Maidoor, and Abdulla Saeed Belyoahah, in addition to the CEO of the Foundation.

Mandate

Law No. (13) of 2023 details the Foundation's mandate to support public policies aimed at advancing the educational and medical sectors and encouraging scientific and medical research, apart from developing specialized reports highlighting educational and medical excellence and recognizing new talent and innovation. The Foundation is also tasked with driving excellence and innovation through scholarships, besides designing and managing advanced laboratories, and forging local and international partnerships to further its objectives.

The Foundation is also entrusted with keeping up with developments in knowledge, providing educational opportunities for creative people, highlighting the UAE's efforts in these fields, and organizing events, exhibitions, conferences, workshops, specialized programs, translation, and publishing in fields related to achieving its goals.

It aims to recognize and honor





individuals and institutions showing a readiness to assume volunteer responsibilities by providing medical or educational services amid natural disasters, wars, pandemics, famines, and other such crises. Furthermore, the Foundation seeks to recognize those who publish medical and scientific research papers and actively promote interactions between local scientists and physicians and international research institutions to leverage their expertise for mutual benefit.

accordance with the abovementioned law, the Hamdan bin Rashid Al Maktoum Foundation for Medical and Educational Sciences will have a supreme president, who will be appointed by a decree issued by His Highness the Ruler of Dubai, and who will carry out the tasks and powers specified in this law and the Foundation's bylaws. The executive body of the Foundation also includes a chief executive officer, who will be appointed by a decision of the Supreme President based on the recommendation of the Board of

Trustees. The law also determined the powers of the Chief Executive Officer of the Foundation, its resources, and its fiscal year.

Transfer

As per the law, all duties and responsibilities of the Sheikh Hamdan bin Rashid Al Maktoum Award for Medical Sciences and the Hamdan bin Rashid Al Maktoum Foundation for Distinguished Academic Performance, established respectively under Decree No. (5) of 1999 and Decree No. (16) of 2018, along with their subsequent amendments, will come under the charge of the Foundation. Furthermore, all assets and employees, including their financial outlay as stipulated in Law No. (1) of 2016 on the Financial Regulations of the Government of Dubai, will be transferred to the newly formed entity. The Foundation will assume all the rights and obligations of these two entities, i.e., the Sheikh Hamdan bin Rashid Al Maktoum Award for Medical Sciences and the Hamdan bin Rashid Al Maktoum Foundation for Distinguished Academic Performance.

Coordination

The Foundation is responsible for coordinating with relevant entities to ensure its operations comply with the new Law within three months of its enactment. The Chairman of The Executive Council, upon the Foundation's request, may extend the deadline if circumstances call for it.

Annulment

The Law annuls Decree No. (5) of 1999 pertaining to the creation of the Sheikh Hamdan Bin Rashid Al Maktoum Award for Medical Sciences; Decree No. (16) of 2018 on the Hamdan bin Rashid Al Maktoum Foundation for Distinguished Academic Performance and their amendments; Decision No. (1) of 2019 relating to the formation of the Board of Trustees of the Hamdan bin Rashid Al Maktoum Foundation for Distinguished Academic Performance; Decision No. (18) of 2022 on the appointment of the Supreme President of the Hamdan bin Rashid Al Maktoum Distinguished Foundation for Academic Performance: and the decision to form the Board of Trustees of the Sheikh Hamdan Bin Rashid Al Maktoum Award for Medical Sciences, dated 24 December 2019.

The Law also annuls any other legislation that may contradict it. Legislations issued to implement Decree No. (5) of 1999 and Decree No. (16) of 2018 remain in place as far as they don't contradict the new Law or other legal provisions in place, until the issuance of other legislations that will replace them.

Law No. (13) of 2023, and Decision No. (58) of 2023 are effective from the date of their publication in the Official Gazette.



The UNESCO-Hamdan Prize is granted every two years to three winners from around the world who provide outstanding educational practices that contribute to improving the performance of teachers in developing countries and marginalized societies.

The prize of up to 300,000 US dollars is divided equally among the three winners.

Nominations for the Prize can be made by individuals representing international and national organizations or institutions, governmental or non-governmental, as well as local, national, and regional educational institutions and associations.

Nomination Process

Individuals cannot apply or be nominated for the prize. It can be national committees and affiliated non-governmental organizations, which must have an official partnership with UNESCO, and the nominating body may nominate up to 5 candidates for the prize.

Applications are accepted in English and French only, and those wishing to participate can review the conditions and apply via the prize website.

The applications will be sorted and transferred to the international judging committee, which includes an elite group of senior experts in the sector.

The total number of participants in the prize since its first session in (2009-2010) until the seventh session (2021-2022) has reached 804 participants. The total number of winners during the seven sessions was 20 institutions.

The three winners of the prize are:

The King Faisal Foundation (KFF) from Saudi Arabia, for its the Alfaisal University project. Founderd in 2002, the university was the first non-profit private university, aiming to contribute to raising the level of education and scientific research.

The total budget for the KFF's projects amounted to 1 billion riyals.

- The Royal Humanitarian Foundation of the Kingdom of Bahrain, for the Bahrain Scientific Complex, which was constructed within the Somali National University and included 7 basic colleges. It reopened the university after a 20-year closure. The Royal Foundation's projects have an estimated budget of US\$ 2 million.
- The Deaf Reach Schools, which was presented by the Family Educational Services Foundation in the Islamic Republic of Pakistan. The entire budget of its educational charitable projects is one million dollars annually. This initiative aims to support the deaf through technology, by offering an integrated curriculum that focuses on educating teachers and training parents in order to hire and integrate deaf people into society.
